Bob announced that a petition had been filed today to see if the Town will rescind Article #20 of the 1991 Annual Town Meeting requiring that 50% of land use change tax revenues be deposited in the Conservation Fund with a maximum of \$10,000 to be deposited in any one year.

Minutes: The minutes of the November 12, 2014 meeting were reviewed and the following corrections made: page 1, correct Dixie's name, page 1 under Trails, add the fourth paragraph to the second paragraph and page 2, first paragraph, first sentence should read "...has erected "no trespassing" signs. The minutes of the November 12, 2014 non public session were reviewed and the spelling of November corrected. Bob made a motion to approve the minutes as amended. Dixie seconded the motion and it

passed unanimously.

**Committee Reports:** 

Lands: Bob distributed a copy of Chapter 36-A:4-a and explained that according to this Chapter the Conservation Commission does not have to put a warrant article on the ballot to continue having the Monadnock Conservancy hold an easement on land. Bob also distributed Chapter 41:14-a and a legal opinion is forthcoming that the RSA only pertains to contributions by the Commission to purchase land which it has no interest in, and that the RSA has no applicability to placing easements on town-owned

conservation land.
